<sup>3</sup> Effective June 1, 2016, this service includes \$10 Judiciary administrative fee and two additional Federal Record Center (FRC) fees: (A) \$9.90 flat rate fee to pull and refile the record(s) and (B) \$0.65 per page fee. The FRC fees are subject to change in accordance with the Inter-Agency Agreement between the AO and the FRC.

<sup>4</sup>Courts may locally establish additional attorney admission fees or Pro Hac Vice admission fees.
